KEY POINTS

- **If you are unwell, you must NOT attend the studio. This applies to all staff, students, parents, siblings, and visitors.**
- **Practice good hygiene by washing your hands upon arrival and after class with sanitiser or soap and water.**
- **It is mandatory that all parents, students - 16 years and older and all visitors must check in via their SafeWA app if entering the building. A QR Code is provided at the door (preferable) and a hard copy register is at reception if needed. Younger students will be checked in via our roll call system.**

FACTS OF COVID-19 VIRUS

Coronavirus (COVID-19) is a highly transmissible virus spread through small droplets from the nose or mouth via talking, coughing, sneezing, or exhaling. Symptoms can include fever, chills or sweats, cough, sore throat, shortness of breath, runny nose, or loss of sense of smell. In certain circumstances, headache, muscle soreness, stuffy nose, nausea, vomiting and diarrhoea may also be considered.

PREVENTION

The best way to prevent transmission is to stay home if you are unwell, practice social distancing and ensure good personal hygiene.

- **Wash your hands often with soap and water for at least 20 seconds, especially after blowing your nose, coughing, sneezing, or using the toilet.**
- **Avoid touching your eyes, nose, and mouth with unwashed hands.**
- **Cough or sneeze into your elbow.**
- **Do not share drink bottles.**

WHAT IMPACT DANCE FACTORY IS DOING TO MINIMISE THE RISK OF COVID-19

- **Enforcing Safe WA check in's and having accurate records of younger students who attend our dance studio.**
- **Anyone entering the building is required to use hand sanitiser or wash their hands with soap and water.**
- **All staff have completed COVID-19 Infection Control Training and are fully vaccinated.**
- **All administrative queries will be handled via email.**

- **Full studio covid-19 cleaning is maintained on a regular basis.**

If anyone is diagnosed with Covid-19 or has been in contact with anyone while infectious, we will immediately consult with the Department of Health WA for guidance. The Department of health may require us to close for a short period to facilitate cleaning and enable contact tracing.

Professional cleaners will be brought in to thoroughly clean all areas of the studio before re-opening.

We will respect the privacy of anyone with a confirmed case of coronavirus and treat their condition with understanding and compassion.

Any person who tests positive for Covid-19 must remain in home isolation until they have been notified by Department of Health WA that they have met the criteria for release from isolation.

Any person who is determined to be a close contact of a person with Covid-19 by the Department of Health WA, should not attend the studio for 14 days after their last close contact and must self-isolate. During isolation, they should watch for symptoms and seek medical assessment and testing if they become symptomatic.

Contact details for students and parents may be passed on to the Department of Health WA for the purpose of contact-tracing if necessary.
